STATEMENT AND TERMS OF PAYMENT

All dues are payable upon receipt of invoice. Contractors have the option of paying their dues annually or quarterly with a credit card on file.

Members are responsible for payment of past dues amounts on their accounts even if they wish to cancel their membership. Any member in arrears on quarter (90 days) will be automatically dropped from the membership roster; however they are still liable for all past amounts. Written notification must be received by the Association office to terminate membership. Non-payment is not considered a method of terminating membership.

For those that terminate or lapse membership all past due amounts must be paid prior to membership reinstatement. It is expected that all events will be paid for in advance or at the door. **Reservations are required.** Anyone who makes a reservation is responsible for payment of the reservation.
